EXPLANATORY NOTE

Bylaw No. 4703 is a Bylaw respecting the enforcement of bylaw notices within the Township of Langley as in accordance with the *Local Government Bylaw Notice Enforcement Act*, S.B.C. 2003, c. 60 as amended.

Amending Bylaw No. 4795 – adopted March 22, 2010

Bylaw 4795 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide provisions relating to the new Highway and Traffic Bylaw 2010 No. 4758.

Amending Bylaw No. 4826 – adopted April 11, 2011

Bylaw No. 4826 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide for fine amounts and offences for the recently adopted Property Safety Bylaw 2010 No. 4834, and further to include additional housekeeping amendments to existing schedules.

Amending Bylaw No. 4872 – adopted May 16, 2011

Bylaw No. 4872 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide for fine amounts and offences for the recently adopted Solid Waste Management Bylaw 2011 No. 4845, and further, to include additional designated bylaw enforcement officers to Section 13(d).

Amending Bylaw No. 4928 – adopted July 9, 2012

Bylaw No. 4928 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide for provisions relating to the new Sign Bylaw 2012 No. 4927 and additional housekeeping changes.

Amending Bylaw No. 4973 – adopted March 4, 2013

Bylaw 2013 No. 4973 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide ticketing provisions relating to secondary suite licensing requirements set out in the Township of Langley Business Licence Bylaw 2001 No. 4050 as amended.

Amending Bylaw No. 5004 – adopted May 13, 2013

Bylaw 2013 No. 5004 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to account for provisions and additional housekeeping changes to the Township of Langley's Water Shortage Response Bylaw 2012 No. 4909, and the Watercourse Protection Bylaw 2012 No. 4964.

Amending Bylaw No. 5007 – adopted June 24, 2013

Bylaw 2013 No. 5007 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to include provisions relating to the Audible Bird Scare Devices Farm Bylaw 2013 No. 5005.

Amending Bylaw No. 5025 – adopted December 2, 2013

Bylaw 2013 No. 5025 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 by deleting references to Offences and Fines listed under repealed “Fireworks Regulation Bylaw 2004 No. 4344” and updating Offences and Fines associated with the new “Fire Prevention Bylaw 2013 No. 4956”.

Amending Bylaw No. 5033 – adopted January 13, 2014

Bylaw No. 5033 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide ticketing provisions relating to the Building Bylaw Amendment Bylaw 2013 No. 5023 as well as additional housekeeping amendments.

Amending Bylaw No. 5062 – adopted February 24, 2014

Bylaw No. 5062 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 by updating page 40, Schedule A, to address amendments to the Property Safety Bylaw 2010 No. 4835.

Amending Bylaw No. 5082 – adopted June 9, 2014

Bylaw 2014 No. 5082 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 by providing provisions relating to Interim Tree Clear-Cutting Bylaw 2014 No. 5080.

Amending Bylaw No. 5108 – adopted September 8, 2014

Bylaw 2014 No. 5108 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 to provide provisions relating to the Highway and Traffic Bylaw 2010 No. 4758.

Amending Bylaw No. 5115 – adopted October 6, 2014

Bylaw 2014 No. 5115 updates the Bylaw Notice Enforcement Bylaw 2008 No. 4703 and incorporates amendments regarding the new offences set out in the Soil Deposit and Removal Bylaw 2013 No. 4975.

Amending Bylaw No. 5122 – adopted January 26, 2015

Bylaw 2015 No. 5122 updates the Township of Langley Bylaw Notice Enforcement Bylaw 2008 No. 4703 to address amendments to the Property Safety Bylaw 2010 No. 4835 and to permit a violation of section 104.3(i)(i) of the Township of Langley Zoning Bylaw 1987 No. 2500 to be addressed through the issuance of a bylaw notice.

Amending Bylaw No. 5155 – adopted May 25, 2015

Bylaw 2015 No. 5155 updates Bylaw Notice Enforcement Bylaw 2008 No. 4703 to address amendments to the Fire Prevention Bylaw 2013 No. 4956 with respect to implementation of an escalating fee structure for false alarms.

Amending Bylaw No. 5173 – adopted November 2, 2015

Bylaw 2015 No. 5173 amends Notice Enforcement Bylaw 2008 No. 4703 by removing references to the Township of Langley Noise Control Bylaw 1988 No. 2573 and permitting a violation of Noise Control Bylaw 2015 No. 5172 to be addressed through the issuance of a bylaw notice.

Amending Bylaw No. 5047 – adopted January 11, 2016

Bylaw 2015 No. 5047 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 by adding a new schedule relative to Election and Political Signs to Schedule “A” – Designated Bylaw Contraventions and Penalties.

Amending Bylaw No. 5193 – adopted April 25, 2016

Bylaw 2016 No. 5193 updates the Township of Langley Bylaw Notice Enforcement Bylaw 2008 No. 4703 to remove references to the Township of Langley Business Licence Bylaw 2001 No. 4050 and to insert appropriate references to the Licencing Bylaw 2016 No. 5192.

Amending Bylaw No. 5209 – adopted May 30, 2016

Bylaw 2016 No. 5209 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 by adding items to the Solid Waste Enforcement Schedule to include contraventions and penalties related to Litter and Illegal Dumping as outlined in Township of Langley Solid Waste Bylaw 2011 No. 4845, as amended.

Amending Bylaw No. 5201 – adopted May 30, 2016

Amending Bylaw No. 5237 – adopted December 16, 2016

Bylaw 2016 No. 5237 updates the Township of Langley Bylaw Notice Enforcement Bylaw 2008 No. 4703 to permit a violation of the Township of Langley Cemetery Bylaw 2016 No. 5236 to be addressed through the issuance of a bylaw notice.

Amending Bylaw No. 5250 – adopted December 16, 2016

The purpose of Amendment Bylaw 2016, No. 5250 is to provide fine amounts and offences relating to the Shopping Cart Bylaw 2016 No. 5249.

Amending Bylaw No. 5257 – adopted June 12, 2017

Bylaw 2017 No. 5257 amends Bylaw Notice Enforcement Bylaw 2008 No. 4703 by providing provisions relating to Schedule 3 (Development Permit Areas: Streamside Protection and Enhancement) of the Langley Official Community Plan Bylaw 1979 No. 1842.

BYLAW NOTICE ENFORCEMENT BYLAW 2008 NO. 4703

WHEREAS the *Local Government Bylaw Notice Enforcement Act, S.B.C. 2003, c. 60 as amended*, provides that a local government may deal with the contravention of a bylaw by a bylaw notice.

NOW THEREFORE, the Municipal Council of the Corporation of the Township of Langley, in Open Meeting Assembled, ENACTS AS FOLLOWS:

Title

1. This Bylaw may be cited for all purposes as “Bylaw Notice Enforcement Bylaw 2008 No. 4703”.

Severability

2. If a portion of this bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

Definitions

3. In this bylaw:

“**Act**” means the *Local Government Bylaw Notice Enforcement Act, SBC 2003, c60*.

“**Municipality**” means the Corporation of the Township of Langley.

“**Registry**” means the Corporation of the Township of Langley Bylaw Notice Adjudication Registry established under section 9 of this bylaw.

Bylaw Contraventions

4. Council hereby designates the bylaw contraventions specified in Schedule “A” of this Bylaw as bylaw contraventions which may be dealt with by bylaw notice. If a bylaw contravention specified in Schedule “A” is a continuing contravention, each day that the contravention is continued constitutes a separate and distinct contravention.

Penalty

5. The penalty for a contravention referred to in Section 4 is as set out in column 3 of Schedule “A”.

Period for paying a Disputed Notice

6. A person who receives a bylaw notice must within 14 days of the date on which the person received or is presumed to have received the bylaw notice,
 - (a) pay the penalty
 - (b) request dispute adjudicationby filling in the appropriate portion of the bylaw notice indicating either a payment or a dispute and delivering it, either in person during regular office hours, or by mail to the Municipal Hall.
7. A person may pay the indicated penalty after 14 days of receiving the notice, but no person may dispute the bylaw notice more than 14 days after receiving the bylaw notice.
8. Where a person was not served personally with a bylaw notice and advises the Municipality that they did not receive a copy of the original notice, the time limits for responding to a bylaw notice under Sections 6 & 7 of this bylaw do not begin to run until a copy of the bylaw notice is re-delivered to them in accordance with Section 25 of the *Act*.

Bylaw Notice Dispute Adjudication Registry

9.
 - (a) The Registry is established as a bylaw notice dispute adjudication system in accordance with the *Act* to resolve disputes in relation to bylaw notices.
 - (b) The civic address of the Registry is 20338-65th Avenue, Langley, B.C., V2Y 3J1.
 - (c) Every person who is unsuccessful in a dispute adjudication in relation to a bylaw notice or a compliance agreement under the dispute adjudication system established under this section must pay the Municipality an additional fee of \$25 for the purpose of the Municipality recovering the costs of the adjudication system.

Screening Officers

10. The position of screening officer is established.

11. The following are the designated classes of persons that may be appointed as screening officers:

- (a) Manager of Bylaw Enforcement
- (b) Senior Bylaw Officer
- (c) Bylaw Enforcement Clerk

and Council may appoint screening officers from these classes of persons by name or office or otherwise.

Powers, Duties and Functions of Screening Officers

12. The powers, duties and functions of Screening Officers are established in the *Act*, and include the following:

- (a) Where requested by the person against whom a contravention is alleged, Communicate information respecting the nature of the contravention, the provision of the bylaw contravened, the facts on which the contravention allegation is based, the penalty for a contravention, the opportunity to enter into a compliance agreement, the opportunity to proceed to the bylaw notice dispute adjudication system and the fee or fees payable in relation to the bylaw notice enforcement process;
- (b) To communicate with any or all of the following for the purposes of performing their functions under this bylaw or the *Act*:
 - i. the person against whom a contravention is alleged or their representative;
 - ii. the officer issuing the notice;
 - iii. the complainant or their representative;
 - iv. Municipal staff and records regarding the disputant's history of bylaw compliance.
- (c) To prepare and enter into compliance agreements under the *Act* with persons who dispute bylaw notices, including to establish terms and conditions for compliance that the Screening Officer considers necessary or advisable, including time periods for payment of penalties and compliance with the bylaw;
- (d) To cancel bylaw notices in accordance with the *Act* or the Municipal Policies and guidelines;
- (e) The maximum term of a compliance agreement is one year.

Bylaw Enforcement Officers

13. Persons acting as any of the following are designated as bylaw enforcement officers for the purposes of this bylaw and the *Act*:

- (a) members of the Royal Canadian Mounted Police;
- (b) Bylaw Enforcement Officers appointed pursuant to the *Community Charter and Police Act*.
- (c) local assistants to the Fire Commissioner under Section 6 of the *Fire Services Act*;
- (d) Manager of Bylaw Enforcement, Senior Bylaw Officer, Bylaw Enforcement Officer, Animal Control Officer, Chief Inspector, Assistant Chief Inspector, Building Inspector, Business Licence Inspector, Director of Engineering, Manager of Operations, Engineering Technologists, Soil Conservation Officer, Design and Construction Technologist, Utilities Controller, Foreman III, Utilities Manager, Assistant Utilities Manager, Manager Water Resources, Water Resource Engineer, Infrastructure Assets and Solid Waste Manager, Solid Waste Coordinator I, Solid Waste Coordinator II, Environmental Coordinator I, Environmental Coordinator II, Development Engineering Technologist, Erosion and Sediment Control Coordinator, Facility Manager, Facility Service Worker 2, Parks Foreman, or other persons acting in another capacity on behalf of the Municipality, for the purpose of enforcement of one or more of its bylaws.
